# #ReinventPA – Making Government Work Better for You

## **#ReinventPA**

**Pension Reform (Act 5 of 2017):** Aims to slow the growth of pension liabilities, shift risk away from taxpayers and ensure the Commonwealth can meet its future pension obligations. The law establishes three new public pension plans from which state employees and teachers hired in 2019 or later can choose. Each offers a defined contribution component, similar to a 401(k) commonly offered to workers in the private sector. The plans provide future employees with retirement security and portability while also protecting taxpayers. Current employees will have the opportunity to opt in to a new plan or continue in their current plan, and retirees would not see any changes to their plans.

**Office of Inspector General (Act 29 of 2017):** Makes the Office of Inspector General a permanent part of state government, grants the office subpoena power for its internal investigations, and authorizes the office to investigate and file criminal charges for certain welfare fraud crimes.

**Performance-Based Budgeting Act (Act 48 of 2017) –** Establishes performance-based budget recommendations and reviews by the Independent Fiscal Office and an independent board to enhance and improve budget development and decision making associated with the annual budget process. The reviews will look at state agencies and make recommendations to make operations and programs more transparent, effective and efficient.

## ***Bills Awaiting Further Legislative Action***

**Issuing Birth Certificates (HB 84 – awaiting Senate action):** Amends the Vital Statistics Law to improve and speed up the process for issuing birth certificates in the Commonwealth.

**Legislative Reduction (HB 153):** Proposes to amend the Constitution of the Commonwealth of Pennsylvania to reduce the size of the House of Representatives from 203 districts to 151. A constitutional amendment must pass the General Assembly in two consecutive sessions. This measure was passed in the 2015-16 session and is awaiting consideration this session.

**Results First in Budgeting (HB 599 – awaiting Senate action):** Establishes the Results First Project and requires the Independent Fiscal Office to implement and maintain a multidimensional data analyzing system.

**Budget Reforms (House Bills 1940-1945 – awaiting Senate action):** The bills aim to bring more accountability and transparency to state government and rein in excessive government spending. The bill package includes:

- **HB 1940**, which would close a loophole that has allowed out-of-balance budgets to become law because the governor has failed to sign an official revenue estimate indicating whether sufficient funds exist to pay for it.
- **HB 1941**, which would set reasonable time limits on budgetary waivers before unused funds are returned to the State Treasury. Currently, funds can lapse indefinitely.

- **HB 1942**, which would require the Secretary of the Budget in December of a fiscal year to determine if revenues will fall short of the official estimate, and if so, by how much. That amount of funding would then have to be placed in budgetary reserve to avoid ending the fiscal year with a deficit.
- **HB 1943**, which would make special funds – those funds with a dedicated source of revenue to be used for a specific purpose – more transparent, open and accountable.
- **HB 1944**, which would require annual reports to show the cost of state and federal mandates by the administration, including funds used as federal matching funds, and which are entitlements. This legislation would also require the governor to present legislative language in the annual budget proposal process.
- **HB 1945**, which would require the administration to submit a statement of the need for supplemental appropriation and recommendations for cost-savings or other reforms which address the cause of the need for the supplemental appropriation.

**Spending Cap (HB 110 – awaiting Senate action):** Proposes a state constitutional amendment to limit state spending by imposing a cap based on recent increases in the Consumer Price Index and state population growth. A constitutional amendment must be approved in two consecutive legislative sessions and then by the state’s voters.

**Regulatory Reforms (HBs 209, 1237, 1792, 1959 and 1960 -- awaiting Senate action):** These bills aim to cut government red tape and reduce burdensome regulations while still maintaining the integrity of health and safety regulations.

- **HB 209** establishes the Independent Office of the Repealer to review statutes and regulations for possible revision/repeal.
- **HB 1237** establishes an enhanced review process for major regulations that impose substantial cost burden on the Commonwealth.
- **HB 1792** gives the General Assembly the ability to initiate the repeal of any regulation in effect in Pennsylvania by a concurrent resolution and prohibits that regulation from being promulgated in the future unless authorized by law.
- **HB 1959** reforms the administration of permits by state agencies.
- **HB 1960** requires each state agency to designate an employee as the agency’s regulatory compliance officer.

**Online Transparency Portal (HB 1843 – awaiting Senate action):** Requires the State Treasurer to develop and maintain a publicly accessible online transparency portal with information relating to the Commonwealth’s finances.

### **Liquor Sales Reforms**

**Streamlined Licensing (Act 75 of 2017):** Amends the Liquor Code to modernize interlocking business prohibitions.

## ***Bills Awaiting Further Legislative Action***

**Spirits Sales (HB 438 – awaiting Senate action):** Establishes a Spirit Expanded Permit, allowing restaurant and hotel liquor license holders to sell up to four unopened bottles of spirits in a single transaction for off-premise consumption.

**Free the Wine (HB 975 – awaiting Senate action):** Divests the wholesale system of wine by allowing retailers to negotiate pricing on products and allowing those products to be delivered directly to retail markets; provides additional retail outlets to sell wine; allows wine to be sold in grocery store aisles and be purchased at the point of sale with other goods; and increases the amount of wine that can be sold in a single transaction.

**Private Wine and Spirits Sales (HB 991 – awaiting Senate action):** Creates wine and spirit retail store licenses, allowing private entrepreneurs to sell wine and liquor through a new class of state-awarded retail licenses designed to boost customer convenience and choices.

**Wine and Spirits Sales (HB 1033 – awaiting Senate action):** Creates a Wine Enhanced Permit and a Spirits Enhanced Permit to allow a permit holder to sell unlimited quantities of wine and/or spirits for consumption off the premises.

**Wholesale Divestiture (HB 1075 – awaiting Senate action):** Divests the wholesale system for both wine and spirits and creates a State Stores Operating Fund.

**Alcoholic Hard Cider (HB 1497 – awaiting Senate action):** Requires alcoholic cider be primarily derived from apples, apple juice concentrate and water or from pears or pear juice concentrate and water; expands the definition of a public venue under the law; amends eligibility for wine and spirits auction permits to include any community-based voluntary health organization committed to fighting cancer; prohibits placement of a ballot question on a special election ballot; and allows performing arts facilities to serve liquor and malt brewed beverages from 10 a.m. to 10 p.m. on Sundays.

## **Taxpayer Protection**

**Unemployment Compensation System Funding (Act 1 of 2017):** Amends the Unemployment Compensation Law to provide \$15 million in funding to the Service and Infrastructure Improvement Fund (SIIF) in 2017; allocates the funding and requires monthly reports on expenditures; and requires the Department of Labor and Industry to submit a report on ending reliance on SIIF and submit a funding request for upgrades to the Unemployment Compensation benefit delivery system.

**Payments to Local Tax Collectors (Act 38 of 2017):** Amends the Local Tax Collection Law to prohibit tax payments to an account in the name of an individual and requires the creation of a separate account to be used solely for tax payments.

**Lottery Winnings and Delinquent Taxes (Act 44 of 2017):** Allows for a Pennsylvania Lottery winnings intercept for state delinquent taxes and outstanding court costs, and requires a determination as to whether a winner receiving public assistance remains eligible.

**Managing Capital Debt (Act 45 of 2017):** While enacting the 2017-18 Capital Budget, the new law reduces the Redevelopment Assistance Capital Program (RACP) borrowing capacity – with an immediate lessening of the maximum borrowing amount by \$100 million and then reducing the figure further, annually, by \$50 million annually over the next four years.

**UC Funding Fix (Act 60 of 2017):** Provides funding for Unemployment Compensation operations/technological upgrades and requires the Department of Labor to end its reliance on the Service and Infrastructure Improvement Fund.

**Lobbying Disclosure Changes (Act 2 of 2018):** Increases fines and penalties for violations of the Lobbying Disclosure Act. Specifically, it would increase the maximum penalty imposed by the Ethics Commission from the current fine of \$2,000 to \$4,000, and it would increase the maximum administrative penalty that may be imposed for negligent failure to report under current law from \$50 per day, to \$50 for the first 10 days, \$100 for each late day after the first 10 late days and \$200 for each late day after the initial 20-day period.

**Consolidated Collection Clarifications (Act 18 of 2018):** Amends the Local Tax Enabling Act (Act 511 of 1965) to clarify certain provisions related to the consolidated collection of local income taxes and delinquent taxes.

### *Bills Awaiting Further Legislative Action*

**Debt Amortization Guidelines (HB 83 – awaiting Senate action):** Amends the Capital Facilities Debt Enabling Act to require that, except in cases of refunding bond issuance, all debt amortization must be done using an equal annual maturities plan (level principal payments over the life of the bonds).

**No Public Assistance for Drug Dealers (HB 129 – awaiting Senate action):** Prohibits individuals convicted of drug distribution crimes from receiving certain public assistance benefits.

**PSERS Limitations (HB 205 – awaiting Senate action):** Amends the Public School Employees' Retirement Code to make future Pennsylvania School Boards Association employees ineligible to be members of the Public School Employees' Retirement System.

**Inheritance Tax Exemption (HB 291 – awaiting Senate action):** Eliminates Pennsylvania's inheritance tax for property transfers from a natural parent, adoptive parent or step-parent to or for the use of their child, if the child is 21 years of age or younger.

**SRBC Pension Program (HB 922 – awaiting Senate action):** Removes future employees of the Susquehanna River Basin Commission from the State Employees' Retirement System.

**Pension Forfeiture (HB 939 – awaiting Senate action):** Holds state, county and municipal government officials, state employees, judges, teachers and other school district employees accountable for crimes related to their official duties by requiring them to forfeit their government pension and pay appropriate restitution when they plead guilty or no contest to any crime related to their official government position or any felony offense related to their office or employment.

**Proof of Citizenship Public Benefits (HB 1095 – awaiting Senate action):** Establishes the Proof of Citizenship for Receipt of Public Benefits Act.

**No Welfare Benefits for Deceased People (HB 1588 – awaiting Senate action):** Requires the Department of Aging to cross reference its list of beneficiaries with death records maintained by the Department of Health on a monthly basis.

**SNAP Work Requirements (HB 1659 – awaiting Senate action):** Prohibits the Department of Human Services from requesting work requirement waivers for the Supplemental Nutrition Assistance Program (SNAP).

**Medical Assistance Work Requirements (HB 2138 – awaiting Senate action):** Amends the Human Services Code to add work requirements for eligible, able-bodied enrollees in Medical Assistance. The bill includes several exceptions, including pregnant women, persons serving as primary caregiver to a dependent 6 years of age or one who is permanently disabled, and residents who are either under 20 or 65 and older.

### **Property Tax Reform**

**Homestead Exclusion (HB 1285 – approved by voters, November 2017):** Makes a change to the Pennsylvania Constitution to allow local taxing authorities to exclude from taxation up to 100 percent of the assessed value of the homestead property receiving the exclusion.

# Standing Up for Taxpayers... the State Budget

## **2017-18 State Budget**

**2017-18 Budget (Act 1A of 2017 – without the governor’s signature):** General Fund budget for fiscal year 2017-18. The budget would spend \$32 billion, an increase of less than 1 percent over the 2016-17 fiscal year. It includes no new or increased taxes while investing in education at record levels, as well as public safety and human services. It begins the process of government reinvention in calling for mergers of some government departments, as well as by reducing or eliminating outdated programs and expenditures.

**Non-Preferred Appropriations (Acts 11A to 15A of 2017):** Appropriates funding to the following state-related institutions:

- University of Pennsylvania for veterinary activities and the Center for Infectious Diseases: \$30.416 million. (Act 11A)
- Pennsylvania State University: \$252.51 million. (Act 12A)
- University of Pittsburgh: \$146.973 million. (Act 13A)
- Temple University: \$150.586 million. (Act 14A)
- Lincoln University: \$14.436 million. (Act 15A)

**Administrative Code (Act 40 of 2017):** Outlines implementation of the 2017-18 General Fund Budget.

**Tax Reform Code (Act 43 of 2017):** Outlines a means of closing the gap in funding the 2017-18 budget, including securitizing the Tobacco Settlement Fund, ensuring third-party online sellers remit the sales tax, and legalizing and applying a sales tax to fireworks. The bill DOES NOT include any broad-based sales or income tax increases, or taxes on consumer utility bills.

**Fiscal Code (Act 44 of 2017):** Outlines implementation of the 2017-18 General Fund Budget, including various fund transfers from underused accounts to balance the budget.

**Managing Capital Debt (Act 45 of 2017):** Reduces Redevelopment Assistance Capital Project (RACP) debt by \$300 million over four years, adjusts the Commonwealth’s debt issuance procedures and outlines the capital budget for 2017-18.

**Capital Budget Projects (Act 52 of 2017):** Capital Budget Project Itemization for fiscal year 2017-18.

**2017-18 School Code Bill (Act 55 of 2017):** Increases funding for basic, special and early childhood education, setting a record high \$11.86 billion in funding for PreK-12 education; protects excellent teachers by ending the practice of seniority-based layoffs and instead requiring teacher performance to guide furlough and reinstatement decisions; expands student learning options through increases in the Educational Improvement and Opportunity Scholarship tax credit programs; and enhancing drug abuse prevention at agriculture education opportunities.

**2017-18 Human Services Code (HB 59 – VETOED BY THE GOVERNOR):** Makes a variety of changes to the state’s Human Services Code to help implement the 2017-18 state budget. Among the changes is a requirement that the Department of Human Services seek a waiver from the federal government to require reasonable work requirements for those who are physically and mentally able to do so in order to receive benefits. The original bill allowed parents who adopt a child or children to appeal to the Pennsylvania Department of Human Services the amount of an adoption subsidy provided by local authorities.

## **2018-19 State Budget**

**2018-19 Budget (Act 1A of 2018 – first full budget bill signed by Gov. Tom Wolf):** General Fund budget for fiscal year 2018-19. The budget would spend \$32.7 billion, a 1.7 percent increase in over the prior year’s budget. The spending increase falls below the rate of inflation (2.13 percent) and the Taxpayer Bill of Rights rate (2.27 percent). The measure includes no new or increased taxes and effectively eliminates the budget deficit for which the Wolf Administration claimed the only way out was to increase taxes. It makes record investments in PreK-12 education (\$12.3 billion) and establishes a new \$60 million school safety block grant program to ensure Pennsylvania students have a safe environment in which to learn. The budget also:

- Allows the Pennsylvania State Police to train three new cadet classes, which will add an additional 285 troopers to protect communities throughout the state.
- Provides an increase of \$5.5 million for nursing homes rates.
- Takes care of Pennsylvanians with intellectual disabilities, allowing services for an additional 965 people living with intellectual disabilities.
- Supports evidence-based home visiting services to 800 families affected by the opioid epidemic.
- Increases Medicaid reimbursement rates for Emergency Medical Services agencies throughout the Commonwealth.

**Non-Preferred Appropriations (Acts 11A-15A of 2018):** Appropriates funding to the following state-related institutions:

- Pennsylvania State University: \$260.08 million. (Act 11A)
- University of Pittsburgh: \$151.382 million. (Act 12A)
- Temple University: \$155.104 million. (Act 13A)
- Lincoln University: \$14.869 million. (Act 14A)
- University of Pennsylvania for veterinary activities and the Center for Infectious Diseases: \$31.328 million. (Act 15A)

**2018-19 Public School Code (Act 39 of 2018):** Increases funding for basic, special and early childhood education, setting a record high \$12.3 billion in funding for PreK-12 education; invests \$30 million in career and technical education to help prepare students for the jobs of today and tomorrow; boosts funding for higher education by 3 percent for community colleges and state-related universities and 3.3 percent for State System of Higher Education schools; and increases funding for the Educational Improvement Tax Credit by \$25 million. The measure also:



- Requires the Pennsylvania Department of Education to make information available on its website about the College Navigator Website and High Priority Occupations and requires school entities to annually provide this information to high school students (HB 1448).
- Allows public school entities to go into executive session to discuss issues related to school safety when necessary (HB 2327).
- Sets requirements for school entities to enter into a contract with a third party for non-instructional services (HB 1914).
- Eliminates the April 1 to August 1 timeframe for textbook adoption in certain school districts (HB 2432).
- Establishes new vocational instructional certification requirements to attract more qualified career and technical educators (HB 2155).
- Requires one security drill per school year in place of a fire drill and allows schools to conduct two additional school security drills in place of two fire drills (HB 2215).
- Specifies school districts may excuse a student from school attendance to participate in a musical performance in conjunction with a national veterans' organization or funeral (HB 1478).

**Boosting School Safety/ School Safety Block Grant Program (Act 44 of 2018):** Among other things, outlines implementation of a new \$60 million School Safety Block Grant program which is funded in the 2018-19 state budget. Every school will be eligible to apply for funding to pursue safety initiatives that best meet their individual needs, such as security cameras, safety assessments, metal detectors, school resource officers and other critical resources. The measure also establishes a School Safety and Security Committee within the Pennsylvania Commission on Crime and Delinquency to establish criteria for school safety and security assessments. The underlying bill establishes the Safe2Say Program, which allows anonymous reporting of unsafe or threatening activities in schools.

**2018-19 Human Services Code (Act 40 of 2018):** Makes a variety of changes to the state's Human Services Code to help implement the 2018-19 state budget. Among other things, the measure requires the Department of Human Services (DHS) to amend the Medicaid State Plan to provide nonemergency medical transportation services to eligible and enrolled MA recipients using a statewide or regional full-risk brokerage model. This is expected to provide significant savings to the Commonwealth. The underlying bill (HB 1677) amends the Human Services Code to update references of "child day care" or "day care" with "child care."

**2018-19 Fiscal Code (Act 42 of 2018):** Outlines implementation of the 2017-18 General Fund Budget. Among other items, the bill also:

- Implements the fund transfer to the Rainy Day Fund – the first such transfer since 2006! The amount, to be determined in October, will be 50 percent of the surplus leftover from the 2017-2018 FY.
- Establishes the **Keystone Scholars** program within the state Treasury. The program establishes a \$100 scholarship grant account at birth for every newborn who is a Pennsylvania resident or adopted by a Pennsylvania family to be invested in a PA 529 account for higher education. The program will be funded from existing surplus

investment earnings within the state Treasury's PA Guaranteed Savings Program, as well as philanthropic donations. No taxpayer funds will be used.

- Funds **Access to Justice Program (part of SB 741 – awaiting Senate concurrence)** for “civil legal assistance to poor and disadvantaged persons in this Commonwealth.” Judicial fees will increase from \$10 to \$12 and directs the additional \$2 be deposited into the Access to Justice Account. The bill also removes the sunset provision of the Access to Justice Act.

## **GAMING**

**Gaming Expansion (Act 42 of 2017):** Expands gaming opportunities in the Commonwealth by authorizing iLottery, legalizing iGaming, authorizing the auction of 10 Category 4 slot machine licenses, permitting VGTs at truck stops and regulating fantasy sports.

### ***Bills Awaiting Further Legislative Action***

**Airport 50/50 Raffles (HB 864 – awaiting Senate action):** Authorizes designated international airports to conduct 50/50 raffles.

# Improving Our Schools, Investing in Our Kids

## Education

**Civil Immunity for Epinephrine Administration (Act 2 of 2017):** Applies civil immunities to school bus drivers or crossing guards who administer an epinephrine auto-injector to a student.

**Alternatives to Keystone Exam (Act 6 of 2017):** Creates an alternative pathway for career and technical education (CTE) students to demonstrate readiness for high school graduation and removes the statutory requirement for the development and implementation of additional Keystone Exams.

**2017-18 School Code Bill (Act 55 of 2017):** Increases funding for basic, special and early childhood education, setting a record high \$11.86 billion in funding for PreK-12 education. The law includes several changes beneficial to schools, students and teachers, including:

- **Protects Excellent Teachers:** Ends the practice of seniority-based layoffs and instead requires teacher performance to guide furlough and reinstatement decisions. It also allows economic-based furloughs.
- **EITC Expansion/OSTC Preservation:** Expands student learning options through increases in the Educational Improvement Tax Credit program and preserves the successful Opportunity Scholarship Tax Credit program.
- **Strengthening Agriculture Education:** Creates a uniform agriculture curriculum based on high priority occupations, and provides support with state and local FFA programs.
- **College Credits:** Expands the Transfer and Articulation Program to include credits for matriculating freshmen who have taken Advanced Placement (AP) exams in high school with scores that qualify them for college course credits.
- **Enhances Drug Abuse Education:** Creates a drug and alcohol abuse recovery high school program and requires further instruction in the prevention of opioid abuse through a model curriculum.
- **Teacher Education (HB 399 – awaiting Senate action):** Requires a teacher preparation program to recommend applicants for certification who meet certain grade point average standards and prohibits teacher preparation programs from requiring education students to obtain a passing score on certain assessments in order to graduate and from including a student's scores on these assessments as a component of a student's course grade.

**Online Education Grants (Act 5 of 2018):** Allow students enrolled in distance or online education programs to be eligible for Pennsylvania state grants.

**Boosting Civics Education (Act 35 of 2018):** Requires students to take a locally developed assessment in civics between grades seven and 12. Schools may opt to use the U.S. Citizens and Immigration Services test.

**Dyslexia and Early Literacy Intervention (Act 37 of 2018):** Extends the Dyslexia and Early Literacy Intervention Pilot Program from three to five years.

**Keystone Scholars Program (Act 42 of 2018/2018-19 Fiscal Code):** Creates the Keystone Scholars program within the state Treasury. The program establishes a \$100 scholarship grant account at birth for every newborn who is a Pennsylvania resident or adopted by a Pennsylvania family to be invested in a PA 529 account for higher education. The program will be funded from existing surplus investment earnings within the state Treasury's PA Guaranteed Savings Program, as well as philanthropic donations. No taxpayer funds will be used.

### *Bills Awaiting Further Legislative Action*

**State Assessments (HB 85 – awaiting Senate action):** Provides a philosophical exemption from state assessments.

**Charter, Cyber Charter School Reform (HB 97 – awaiting further House action):** Makes several changes to the state's laws regarding charter schools, including creating a Charter School Funding Advisory Commission to address funding concerns and requiring charter schools use an academic performance matrix and teacher evaluations, similar to traditional public schools.

**Financial Literacy (HB 429 – awaiting Senate action):** Permits the award of course credit for successful completion of coursework in personal financial literacy during grades 9 through 12.

**Online Course Database (HB 679 – awaiting Senate action):** Requires the Pennsylvania Department of Education to establish a central online clearinghouse which includes an online database of online courses for students in grades 6-12 and to make the clearinghouse accessible to school entities, nonpublic schools, home education programs and the general public.

**Licensure of Online Schools (HB 857 – awaiting Senate action):** Defines an "online school," amends the definition of a "private academic school" to include online schools and permits the licensure of online schools.

**Sun Protection for Students (HB 1228 – awaiting Senate action):** Allows certain sun protection measures for students, including the application of nonprescription sunscreen, during school hours or at a school-sponsored activity. Under current law, only a school nurse can administer sunscreen because it is considered an over-the-counter medication by the Food and Drug Administration.

**Transition Services (HB 1305 – awaiting Senate action):** Requires professional educators providing secondary transition services to special education students to complete training developed by the Pennsylvania Department of Education.

**Instructional Certificates (HB 1386 – awaiting Senate action):** Revises the grade levels and age spans for educator instructional certificates.

**Help for Youth in Foster Care (HB 1745 – awaiting Senate action):** Enacts the Fostering Independence Through Education Act, a tuition and fee waiver program for youth who are or were in foster care.

**Students with Deployed Parents (HB 2052 – awaiting Senate action):** Requires public school entities to provide information and access to support services to a student whose parent or guardian is deployed for active duty.

**Education Debt Awareness (HB 2124 – awaiting Senate action):** Requires institutions of higher education to send annual letters to students with information regarding their education loan debt.

**School Security Drills (HB 2215 – included in Act 39 of 2018, the Public School Code):** Requires school entities to conduct one school security drill per school year in each school building in place of a monthly fire drill and allows an entity to substitute up to two additional security drills in place of two fire drills.

**School Safety (HB 2327 – included in Act 39 of 2018, the Public School Code):** Allows public school entities to go into executive session for school safety discussions.

### **Matching Students with Jobs of Today, Tomorrow**

**Funding for Career and Technical Education (Act 39 of 2018, 2018-19 Public School Code):** Increases funding for career and technical education by \$30 million to help prepare students for the jobs of today and tomorrow.

**Attracting Experienced Instructors (Act 39 of 2018, 2018-19 Public School Code):** Establishes new vocational instructional certification requirements to attract more qualified career and technical educators. Specifically, the law reduces from 78 to 60 the total credit hours required for a Vocational Instructional II Certificate and increases the years of wage-earning experience in the occupation to be taught from two years to four.

### ***Bills Awaiting Further Legislative Action***

**CareerBound Program (HB 25 – awaiting Senate action):** Establishes the CareerBound program, a school-to-work pilot program.

**Promoting Career and Technical Education (HBs 2156-2159 and HBs 2203, 2204 and 2206 – awaiting Senate action):** These bills aim to enhance career and technical education opportunities for students as they prepare to enter the work force:

- **HB 2156** creates the Career and Technical Education (CTE) Partnership Tax Credit Program which allows a tax credit to business firms that contribute to nonprofit career and technical partnership organizations.
- **HB 2157** expedites and simplifies the process by which new programs are approved which allows training to keep up with regional workforce needs, and increase awareness of how to incorporate STEM activities into CTE programs, allowing students to receive credit for their participation.
- **HB 2158** requires the Pennsylvania Department of Education to develop materials outlining workforce needs, including training opportunities and future earning potential, and allows community colleges and other technical and/or trade schools to attend career/college fairs.

- **HB 2159** repurposes the Transfer and Articulation Oversight Committee (TAOC) to oversee, maintain and update an online tool for students which includes all courses with articulation agreements between secondary and post-secondary schools as well as between post-secondary institutions.
- **HB 2203** creates an online one-stop-shop, overseen by Department of Education, in consultation with the Department of Labor and Industry and the Department of Agriculture, for students, parents, educators, and school officials to provide information about the value and impact of CTE, career pathways, data and statistics on employment opportunities and compensation, and postsecondary options and statewide and regional articulation agreements.
- **HB 2204** requires the Department of Education and the Department of Labor and Industry to conduct a complete inventory of existing workforce development programs at both the secondary and postsecondary levels with emphasis on opportunities for business-education partnerships and to share best practices with these entities.
- **HB 2205** requires career and technical education programs to establish Occupational Advisory Committees.
- **HB 2206** requires local Workforce Development Boards (WDB) to include administrators of career and technical centers whose attendance area is covered by the service area of the WDB or representatives appointed from a local school district.

## Supporting Business, Growing Jobs

### **Supporting Private Sector Business, Job Creation**

**Subcontractor Payment Modernization (Act 27 of 2018):** Amends the Contractor and Subcontractor Payment Act to allow a contractor or subcontract to suspend work if payment is not received in accordance with their contract.

**Bonus Depreciation Clarification (Act 72 of 2018):** Improves Pennsylvania’s business tax-competitiveness by ensuring employers can take advantage of economic growth occurring as a result of federal tax changes.

### ***Bills Awaiting Further Legislative Action***

**Small Business Tax Fairness Package (HBs 331 and 333 – awaiting Senate action):** A key to improving the economy is the success of the small businesses, which create 65 percent of Pennsylvania’s jobs. Removing unfair tax obstacles for small businesses allows them to compete effectively, so they can grow more jobs for current and future generations. **House Bill 331** amends the Tax Reform Code to permit tax deferrals for certain like-kind exchanges. **House Bill 333** amends the Tax Reform Code to permit an expense deduction for the cost of certain business property. (A third bill in the package, House Bill 332, is pending action in the House.)

**Commerce Courts (HB 401 – awaiting Senate action):** Authorizes establishment of a “Commerce Court” program within the Superior Court to decide business-related appeals and authorizes the creation of similar “Commerce Court” programs within the Courts of Common Pleas.

**Microenterprise Development (HB 584 – awaiting Senate action):** Allows local governments to develop a micro-enterprise loan program with the goal of offering municipalities an additional economic development and revitalization tool that addresses unemployment through the advancement of microenterprises developed via public-private partnerships.

**Redeveloping Blighted Properties (HB 758 – awaiting Senate action):** Allows developers and property owners to receive a tax abatement incentive once they apply and are approved to rebuild upon an abandoned or blighted property or in a deteriorated area.

**One-Stop Shop for Permitting (HB 1284 – awaiting Senate action):** Enacts the Pennsylvania Business One-Stop Shop Act to provide one-stop services to assist businesses with the permitting process.

**Employment First (HB 1641 – awaiting Senate action):** Establishes the Employment First Program to promote the employment of people with disabilities at competitive wages by Pennsylvania employers.

**Workers’ Compensation Reforms (HB 1840 – awaiting Senate action):** Re-enacts a provision in the Workers’ Compensation Act authorizing Impairment Rating Evaluations (IREs) with changes to comply with the Pennsylvania Supreme Court’s ruling in Protz v. WCAB (Derry Area School District)

with a reduction (to 35 percent) of the impairment threshold, and increases the burial benefit in the act from \$3,000 to \$7,000.

**Maximizing Tax Benefit (HB 2017 – awaiting Senate action):** Amends the Tax Reform Code to update the definition of “taxable income” for purposes of the Corporate Net Income Tax. The measure would reverse a state Department of Revenue bulletin that would make Pennsylvania the only state to fully disallow depreciation on certain assets, which puts the Commonwealth at a disadvantage in the eyes of businesses looking to either locate or expand here.

**Conventional Oil and Gas Well Regulation (HB 2154 – awaiting Senate action):** Establishes the Conventional Oil and Gas Wells Act which relates to conventional wells and well sites only and establishes a program to increase plugging of abandoned wells to reduce methane emissions in the Commonwealth.

### **Agriculture**

**Good Neighbor Agreement (Act 25 of 2017):** Allows the Commonwealth to enter into federal cooperative agreements for the harvest and sale of timber and other activities to improve forest habitats.

**Roadside Farm Stands (Act 35 of 2017):** Amends the Pennsylvania Construction Code Act to exclude roadside farm stands, maple sugar houses and loading/unloading structures at livestock auction facilities from the Uniform Construction Code.

**Noxious Weeds (Act 46 of 2017):** Updates the current list of noxious weeds to include several new weeds that are having an adverse impact on agriculture and wildlife species, as well as the use of water and land in Pennsylvania.

**Agricultural Education (was HB 944; included in 2017-18 Education Code, Act 55 of 2017):** Establishes the Commission for Agricultural Education Excellence to develop a statewide plan for agricultural education and coordinate the implementation of related agricultural education programming with the Department of Agriculture and the Department of Education.

**High Tunnels (Act 15 of 2018):** Exempts high tunnels from the requirements of the Storm Water Management Act.

### ***Bills Awaiting Further Legislative Action***

**Wind Power on Preserved Farmland (HB 187 – awaiting Senate action):** Provides a preserved farmland owner with at least 50 acres the ability to grant a right-of-way to install a wind-power generation system.

**Ag Lands Condemnation (HB 1518 – awaiting Senate action):** Requires the governor, with the consent of the Senate, to appoint two alternate farmer members to the Agricultural Lands Condemnation Approval Board.



**Residential Structure on Preserved Farmland (HB 1550 – awaiting Senate action):** Permits a preserved farmland owner to voluntarily relinquish the right to construct an additional residential structure on the farmland, which could further reduce the value of the property and make it easier to pass on to the next generation. The bill also clarifies that a subdivision for the purpose of a residence is permitted, regardless of whether the residence already exists or needs to be constructed.

**Liming Materials (HB 2034 – awaiting Senate action):** Amends the Agricultural Liming Materials Act to include the chemical element molybdenum (Mo) in the labeling requirements for agricultural liming materials.

### **Environmental Resources and Energy**

**On-Lot Sewage Systems (Act 26 of 2017):** Allows for the use of alternative on-lot sewage systems for planning purposes throughout the Commonwealth.

**Planned Subsidence (Act 32 of 2017):** Exempts planned subsidence caused by bituminous coal mining operations as a source of pollution to waterways if the mining operation has a DEP-approved plan for the restoration of the pre-mining range of flows and biological communities, as well as the pre-mining designated uses of the waterway.

**Emergency Response (Act 16 of 2018):** Allows emergency medical responders (EMRs) and advanced emergency medical technicians to be employed at underground coal mines.

**Funding for Clean Energy, Conservation Projects (Act 30 of 2018):** Authorizes municipalities or counties to establish, by resolution or ordinance, a property assessed clean energy program (PACE). PACE is a financing mechanism that will enable low-cost, long-term funding for energy efficiency, renewable energy and water conservation upgrades to commercial or industrial properties. The upfront capital is then paid back in the form of a voluntary property tax assessment on the specific, improved building. PACE can pay for new heating and cooling systems, lighting improvements, solar panels, water pumps and insulation.

### ***Bills Awaiting Further Legislative Action***

**Liability Protections for Land Owners (HB 544 – awaiting Senate action):** Amends the state's recreational use of land liability law to clarify and expand its protections for landowners and ensure that legal fees are covered for property owners who are found not liable for injuries to recreational users.

**Surface Mining Cessation (HB 1333 – awaiting Senate action):** Clarifies conditions for temporary cessation of surface mining operations to better align them with federal law.

**Conventional Oil and Gas Act (HB 2154 – awaiting Senate action):** Updating the Oil and Gas Act of 1984 to reflect today's conventional oil and gas industry.

## **Transportation**

**Steer Clear Law (Act 20 of 2017):** Increases the fines and suspends the licenses of repeat offenders of Pennsylvania's "Steer Clear" law, which requires drivers to move into a nonadjacent lane to pass an emergency response area, or if that is not possible, to pass the area at a careful and prudent speed reasonable for passing safely.

**Truck Loads (Act 24 of 2017):** Allows trucks to continue to haul certain heavier loads during holiday periods, while keeping the current restriction regarding inclement weather.

**DUI Laws (Act 30 of 2017):** Eliminates the requirement of a person whose operating privileges have been suspended to surrender their driver's license or acknowledge the suspension in order to begin serving a suspension, establishes civil penalties for refusing a chemical test, and makes corrections to ignition interlock provisions.

**Commercial Natural Gas Vehicles (Act 31 of 2017):** Increases the maximum allowable gross weight for commercial vehicles powered by natural gas.

**Drivers with Disabilities (Act 37 of 2017):** Amends the Vehicle Code to add optometrists to the list of medical providers who may certify an application for a disability placard or registration plate.

**Golf Carts (Act 57 of 2017):** Defines the term "golf cart," authorizes the designation of golf-cart crossings and establishes rules of operation for person ages 12 to 16.

**Truck Width (Act 21 of 2018):** Standardizes the current truck-trailer combination width for all trucks at 8 feet, 6 inches (102 inches). Trucks up to this width will be permitted on all highways unless an engineering and traffic study determines that the roadway width is not sufficient. If so, signs would be posted to limit the traffic as determine while allowing for exemptions for narrow roadways. Previous law reflected a standard width of 96 inches (8 feet), but that size trailer is now available only be special order and is costly.

**Bridge Fencing Safety (Act 65 of 2018):** Requires PennDOT to install protective fencing on all newly built bridges with sidewalks, and those existing bridges with a sidewalk which have a concrete barrier installed, modified or rehabilitated. The law aims to prevent objects from being thrown from overpasses and causing severe injury or death to drivers and passengers on the roadways below.

## ***Bills Awaiting Further Legislative Action***

**Motorcycle Plates (HB 26 – awaiting Senate action):** Permits organizational license plates for use on motorcycles and allows for abbreviated portions of an organization's name on special plates.

**Emission Inspection Alternative (HB 86 – awaiting Senate action):** Proposes to replace emission inspection requirements for certain older model vehicles in the Pittsburgh and Philadelphia regions.

**Recreational Trailer Registration (HB 229 – awaiting Senate action):** Establishes an annual registration fee for recreational trailers based on registered gross weight and provides an exemption from registering in combination with the towing vehicle.

**Pediatric Cancer Contribution (HB 407 – awaiting Senate action):** Allows a person renewing a driver's license, identification card or vehicle registration electronically the opportunity to contribute \$5 to pediatric cancer research.

**Historic Military Vehicle Plates (HB 580 – awaiting Senate action):** Creates a Historic Military Vehicle license plate to be made available from the Pennsylvania Department of Transportation.

**Alternative Fuel Vehicles (HB 603 – awaiting Senate action):** Allows for a vehicle that is operated by an engine fueled primarily by compressed or liquefied natural gas to exceed the gross vehicle weight limits and any axle weight limits, not to exceed a maximum of 2,000 pounds.

**Motorcycle Processions (HB 831 – awaiting Senate action):** Outlines rights and responsibilities of people participating in organized motorcycle processions.

**Improper License (HB 1239 – awaiting Senate action):** Enhances the penalty for drivers operating a vehicle or motorcycle without the proper class of license.

**Purple Heart Motorcycle Plates (HB 1294 – awaiting Senate action):** Allows motorcycles to be equipped with a special registration plate for Purple Heart recipients.

**Hauling Permit Fees (HB 1444 – awaiting Senate action):** Assesses an annual hauling permit fee of \$900 for overweight vehicles less than 100,000 pounds with a hauling distance greater than 50 miles, and also allows for the transportation of multiple hot ingots a distance of up to 125 miles.

**Vulnerable Highway Users (HB 1646 – awaiting Senate action):** Defines "vulnerable highway user" and establishes penalties for a person convicted of careless driving that results in the death, serious bodily injury, or bodily harm of a vulnerable highway user (including, but not limited to, a pedestrian; a person on roller skates, inline skates, a skateboard or pedalcycle; a person on an animal or an animal drawn vehicle; a person in a wheelchair).

**Parking Near Bike Lanes (HB 1657 – awaiting Senate action):** Requires vehicles parking along an on-street pedestrian plaza or a curbside bike lane to park parallel with their right-hand wheels or left-hand wheels within 12 inches of the outside line of the buffer area between the bike lane and parking in the direction of traffic flow.

**Truck-Trailer Standards (HB 1699 – awaiting Senate action):** Standardizes the current truck-trailer combination width for all trucks at 8 feet, 6 inches (102 inches), while allowing for exemptions for narrow roadways.

**License Plate Readers (HB 1811 – awaiting Senate action):** Restricts government use of Automated License Plate Reader Systems and outlines restrictions on the preservation and disclosure of captured data and the destruction of data. The bill also sets penalties associated with the misuse of the readers.

**Elimination of Duplicate Fees (HB 1910 – awaiting Senate action):** Eliminates the \$2 and \$6 fees associated with ordering a duplicate vehicle registration card online when that vehicle registration card is printed by the applicant. This exemption does not apply to duplicate registration cards processed by PennDOT or an agent service of PennDOT in an over-the-counter transaction or by mail.

**ATV Updates (HB 1936 – awaiting Senate action):** Makes editorial and reference changes to the Vehicle Code that apply to all-terrain vehicles.

**Highway Safety Measures (HB 1958 – awaiting Senate action):** Allows for the platooning of certain vehicles and authorizes the use of fully autonomous work-zone vehicles by the Pennsylvania Department of Transportation and the Pennsylvania Turnpike Commission.

**Work Zone Cameras (SB 172 – awaiting Senate action):** Creates an automated speed enforcement system (ASES) five-year pilot program for highway work zones and a separate ASES pilot program along Roosevelt Boulevard in the City of Philadelphia.

**Recreational Vehicles (SB 764 – awaiting Senate action):** Amends the Board of Vehicles Act to establish a specific chapter for recreational vehicles.

## Better Health, Safety and Quality of Life

### **Opioids – The Crisis of Addiction**

**Civil Immunity for Epinephrine Administration (Act 2 of 2017):** Applies civil immunities to school bus drivers or crossing guards who administer an epinephrine auto-injector to a student.

**Opioid Abuse Prevention Education (HB 121, included in Act 55 of 2017):** Updates alcohol, chemical and tobacco abuse curricula to include opioid abuse prevention education.

**Certification of Recovery Houses (Act 59 of 2017):** Amends the Administrative Code to require the Department of Drug and Alcohol Programs to license or certify drug and alcohol recovery houses which receive public funding.

**Medical Marijuana Research Projects (Act 43 of 2018):** In response to a Commonwealth Court ruling, clarifies the state's Medical Marijuana Act to help ensure research projects involving medical marijuana are not delayed by the ongoing litigation.

**Consent to Treatment (Act 47 of 2018):** Clarifies that a parent or legal guardian can provide consent, over the objection of a minor, to providing medical care or counseling related to diagnosis or treatment of substance abuse.

**Hospice Drug Disposal (Act 69 of 2018):** Authorizes home health and hospice agencies to properly dispose of unused medications following a patient's discharge or death with the permission of the patient, patient's family, caregiver or health care representative.

**Protecting Injured Workers (SB 936 – VETOED BY THE GOVERNOR):** Amends the Workers' Compensation Act to help combat the opioid crisis, protect injured workers and rein in prescribing abuses in the system. The bill would require the Pennsylvania Department of Labor and Industry (L&I) to adopt an evidence-based prescription drug formulary and requires the Utilization Review Organizations and Peer Review Organizations to be accredited or certified by a nationally recognized organization selected by L&I.

### ***Bills Awaiting Further Legislative Action***

**Project Lazarus Commission (HB 122 – awaiting Senate action):** Establishes the Project Lazarus Commission consisting of legislators and administration officials charged with developing a best practice model to help counties build comprehensive programs to address the opioid crisis.

**Impact on Infants, Children (HB 235 – awaiting Senate action):** Establishes a task force to examine the opioid abuse epidemic's impact on infants and children.

**Electronic Prescriptions (HB 353 – awaiting Senate action):** Aims to reduce the diversion of controlled substances into the wrong hands by requiring electronic prescriptions of Schedule II, III and IV controlled substances.

**Detox Bed Registry (HB 825 – awaiting Senate action):** Requires the Department of Drug and Alcohol Programs to develop and administer an Internet-based detoxification bed registry with information about available beds at licensed provider’s detoxification and rehabilitation facilities for treatment of individuals experiencing substance abuse emergencies.

**Dextromethorphan Sales (HB 1951 -- awaiting Senate action):** Prohibits the sale of dextromethorphan, an ingredient in some cough syrups, to minors to prevent misuse or abuse.

**Dispensing of Fentanyl (HB 1987 – awaiting Senate action):** Limits the dispensing of fentanyl and fentanyl derivatives.

### **Protecting Children**

**Endangering Welfare of Children (Act 12 of 2017):** Increases the grading of offenses related to endangering the welfare of children to reflect the degree of risk and the age of the child victim.

**Newborn Protection Act (Act 68 of 2017):** Allows a parent to leave a newborn with an emergency services provider and also allows a parent to leave a newborn in an incubator located at a hospital, a police station, or on the grounds of an entity employing or providing access to an emergency services provider.

**Expanding Legal Standing in Custody Cases (Act 21 of 2018):** Adds a provision regarding when third parties may file an action for any form of legal or physical custody. Specifically, a third party may file if the person establishes by clear and convincing evidence that he/she: is willing to or has assumed responsibility for the child; has a sustained, substantial and sincere interest in the welfare of the child; and neither parent has any form of care and control of the child.

**Abortion Control Act Updates (SB 3 – VETOED BY THE GOVERNOR):** *Amends the Abortion Control Act regarding abortion regulations, including changing the upper limit of when an elective abortion is available and prohibiting the practice of dismemberment abortions.*

**Child Abuse Investigations (Act 67 of 2017):** Eliminates the sunset provision in the Crimes Code regarding issuance of administrative subpoenas in investigations involving child sexual exploitation or abuse.

**ChildLine Number Display (Act 54 of 2018):** Requires public and nonpublic schools, as well as hospitals, to display a poster with the statewide toll-free telephone number for reporting suspected child abuse or neglect (ChildLine). The measure also extends the timeframe for retention of General Protective Services reports; provides for notification and plan of safe care for substance-exposed infants in compliance with federal law; and changes educational co-op employers to volunteer status with respect to background clearance requirements.

### ***Bills Awaiting Further Legislative Action***

**Indecent Exposure (HB 489 – awaiting Senate action):** Directs the Pennsylvania Commission on Sentencing to provide a sentence enhancement for committing the offense of indecent exposure when a person under the age of 16 is present.

**Children in Hot Cars (HB 1152 – waiting Senate action):** Offers civil immunity for damages that result from entry into a motor vehicle for the purpose of rescuing a child. For such immunity to apply, the person must have a reasonable belief the child is in imminent danger, determine that the child is unable to get out of the vehicle without help, and attempt to locate the driver and contact law enforcement or other emergency responders prior to entering the vehicle.

**Updating Mandatory Reporter Requirements (HB 1527 – awaiting Senate action):** Clarifies that mandated reporters must report suspected child abuse whenever they personally witness an abusive act to an identifiable child.

**Protecting Unborn Children with Down Syndrome (HB 2050 – awaiting Senate action):** Prohibits abortion based on a diagnosis of Down syndrome.

### **Grandparents Raising Grandchildren**

#### ***Bills Awaiting Further Legislative Action***

**Guardianship of Children to Drug-Addicted Parents (HB 1539 – awaiting Senate action):** Allows a grandparent of a child, or other family member related to the child, to petition a court of common pleas for temporary guardianship of that child when a parent of that child has entered a rehabilitation facility for treatment of a drug or alcohol addiction, or has been subject to emergency medical intervention due to abuse of drugs or alcohol.

**Kinship Caregiver Navigator (HB 2133 – awaiting Senate action):** Establishes the Kinship Caregiver Navigator Program to provide an informational resource for grandparents who are raising their grandchildren outside the formal child welfare system.

### **Public Safety/Public Protection**

**Metal Theft (Act 8 of 2017):** Adds the offense of theft of secondary metal, which includes wire, pipe or cable commonly used by communications, gas and electrical utilities, and railroads and mass transit or commuter rail agencies, as well as copper, aluminum or other metal, or combination of metals, that is valuable for recycling or reuse as raw material. The offense is graded based on the value of secondary metal stolen.

**Libre’s Law (Act 10 of 2017):** Updates and clarifies the existing animal abuse statute and increases the penalties for abusing any animal. The bill would apply criminal penalties based on the severity of the offense and divide the types of abuse into three categories: neglect, which would include failure to provide food, water or shelter; cruelty, which would include recklessly overloading, beating or abandonment; and aggravated cruelty, which would include intentionally torturing an animal to the point where it causes bodily injury or death.

**Civil Asset Forfeiture Reform (Act 13 of 2017):** Reforms the state’s civil asset forfeiture process by imposing a higher burden of proof on the Commonwealth to take property, bolstering protections for third-party property owners, improving auditing and recording transparency of collected property, prohibiting the pre-forfeiture seizure of real property without a hearing, and adding an extra level of protection for those who are trying to collect their property after an acquittal.

**Police Body Cameras (Act 22 of 2017):** Removes barriers to the use of body cameras by law enforcement officers, including the previous requirement that an officer must announce to everyone in a public space they are being recorded. The measure also outlines the process by which recordings would be made available to the public.

**Additional Judges (Act 49 of 2017):** Increases the number of judges of the Courts of Common Pleas in seven separate judicial districts within the Commonwealth.

**One Call Law (Act 50 of 2017):** Extends and updates the Underground Utility Line Protection Law, also known as PA One Call, and transfers enforcement authority from the Department of Labor and Industry to the Pennsylvania Public Utility Commission (PUC).

**Crime Victim Representation (Act 51 of 2017):** Increases the number of members appointed by the governor to the Victims’ Services Advisory Committee and ensures broader representation of crime victims on the committee.

**Protecting Against Sex Offenders/Adam Walsh Act (Act 10 of 2018):** Requires the court to impose a mandatory three-year probation period consecutive to and in addition to any other lawful sentence imposed by the court for a person convicted of a Tier III sex offense under Pennsylvania’s Adam Walsh Act.

**Tierne’s Law (Act 14 of 2018):** Clarifies that a magisterial district judge may, in cases of domestic violence, use a pretrial risk assessment tool when considering bail in a criminal case involving domestic violence.

**Protection Against Sex Offenders (Act 29 of 2018):** Amends the Judicial Code regarding the registration of sexual offenders to ensure all offenders must continue registering their location with the Pennsylvania State Police.

**2018-19 Fiscal Code (Act 42 of 2018):** Outlines implementation of the 2017-18 General Fund Budget. The Fiscal Code removes the sunset provision of the Access to Justice Act, and funds it to help “civil legal assistance to poor and disadvantaged persons in this Commonwealth.” Judicial fees will increase from \$10 to \$12 and directs the additional \$2 be deposited into the Access to Justice Account.

**Jurisdiction in Juvenile Cases (Act 49 of 2018):** Clarifies that a minor’s failure to comply with a summary offense sentence constitutes a “delinquent act.” This clarification ensures that the



juvenile courts retain jurisdiction over enforcement of such cases. The measure also clarifies the burden of proof necessary for an order for treatment, supervision or rehabilitation.

**No ARD for Sex Offenders (Act 50 of 2018):** Prohibits Accelerated Rehabilitative Disposition for certain sex offenses against children, including rape, involuntary deviate sexual intercourse and aggravated indecent assault.

**Neglect of Care-Dependent Person (Act 53 of 2018):** Expands the offense of neglect of a care-dependent person that results in death and creates the offense of abuse of a care-dependent person.

**Clean Slate (Act 56 of 2018):** Provides people with low-level, nonviolent criminal records a mechanism to have their record sealed from public view. Specifically, people with nonviolent misdemeanor convictions could have their records sealed only after remaining crime-free for 10 years.

**Non-Municipal Police Response (Act 57 of 2018):** Expands the types of officers who can act outside their jurisdictional boundaries in certain urgent situations to include non-municipal officers who must receive training and be certified under Act 120, the Municipal Police Officers Education and Training Act. This may include officers serving with airport authority, college and university, or certain other police departments, as well as agents in the Office of Attorney General.

**Litter Law Enforcement (Act 62 of 2018):** Mandates community service for scattering rubbish violations and Creates “litter enforcement corridors” and increased penalties for littering within those corridors.

**Elevator Safety (Act 68 of 2018):** Establishes an “Elevator Safety Board” which will have specific jurisdiction over elevator appeals/variances and make recommendations on regulations.

### ***Bills Awaiting Further Legislative Action***

**Identification of Law Enforcement Officer (HB 27 – awaiting Senate action):** Prohibits releasing the name and identifying information of a law enforcement officer involved in a discharge of a firearm or use of force during the performance of official duties before an investigation is complete or before 30 days after the incident has occurred, whichever occurs first.

**Officer Down Advisory System (HB 31 – awaiting Senate action):** Establishes the Pennsylvania Officer Down Advisory System to assist, by prompt notification to the public, in the apprehension of those suspected of causing serious injury or death to a law enforcement officer.

**Precious Metal Sales (HB 41 – awaiting Senate action):** Enhances requirements for precious metal dealers regarding transaction records, item retention and licensing status, purchases from minors and penalties.

**Improving PFA Orders (HB 44 – awaiting Senate action):** Amends the Protection from Abuse Act in order to provide the court with information regarding whether the defendant has been involved with a child abuse investigation.

**Trafficking of Infants (HB 128 – awaiting Senate action):** Increases the penalty for the offense of trafficking of infants to a first-degree felony.

**Recording Court Proceedings (HB 149 – awaiting Senate action):** Prohibits the use of devices to record video or audio or take photographs in a courtroom or hearing room without the permission of the presiding officer or as permitted by the rules of court.

**Collecting Restitution (House Bills 234, 236, 280, 285 – awaiting Senate action):** The following bills aim to help ensure payment of restitution:

- **House Bill 234** requires each county to establish an internal unit dedicated to the collection of restitution, fines, fees and other court-imposed obligations unless the county chooses to outsource collections.
- **House Bill 236** authorizes wage attachment for the satisfaction of restitution, costs and fines, and authorizes additional payment options for the same.
- **House Bill 280** requires that any money posted as bail, which would otherwise be returnable, shall first be applied to the payment of any outstanding restitution, fees, fines or costs owed by the defendant in any criminal or delinquency case.
- **House Bill 285** requires that correctional facilities make minimum deductions from the wages and personal accounts of inmates who have outstanding restitution or other court-ordered obligations.

**Firearm Offenses (HB 348 -- awaiting Senate action):** Requires that the mandatory sentence imposed for an offense committed with a firearm be imposed consecutively, not concurrently, to any other sentence imposed by the court.

**Megan’s Law Requirements (HB 508 – awaiting Senate action):** Prevents convicted sex offenders who are non-compliant in their Megan’s Law registry requirements from receiving welfare benefits.

**Protecting Health Care Workers (HB 646 – awaiting Senate action):** Amends the aggravated assault law to add health care practitioners to the protected class, which outlines a higher grade of offense and penalty if the health care practitioner is assaulted while in the performance of his or her duties.

**Firearms Preemption (HB 671 – awaiting Senate action):** Outlines better enforcement of the state’s preemption of local firearms and ammunition regulations by stating that any party who successfully challenges one of these illegal local firearm ordinances will be entitled to reimbursement from the offending jurisdiction for reasonable attorneys fees and costs to bring the lawsuit, and any loss of income suffered because of the illegal ordinance.

**Spoofing (HB 979 -- awaiting Senate action):** Establishes a misdemeanor offense for any person who causes false caller identification information to be displayed on a recipient's telephone with the intent to harass, cause harm or defraud the call recipient.

**DUI and Driving Without a License (HB 1049 – awaiting Senate action):** Creates a tiered penalty system for driving on a suspended or revoked license as a result of DUI-related offenses and establishes sentencing enhancements for homicide by vehicle and homicide by vehicle while DUI as a result of driving without a license or on a suspended license.

**Concussion Protocol (HB 1176 – awaiting Senate action):** Creates the Law Enforcement Concussion Safety Act which directs the Pennsylvania State Police to develop a concussion protocol to be used by all police departments in the state.

**Animal Fighting (HB 1197 – awaiting Senate action):** Adds animal fighting to the list of offenses that are enforceable under the state's racketeering provisions.

**Pets in Hot Vehicles (HB 1216 – awaiting Senate action):** Offers civil immunity for a person entering a vehicle to rescue a dog or cat. The immunity would apply to law enforcement officers, animal control officers, human society police officers and emergency responders for property damage resulting from the effort to enter the dog or cat. For such immunity to apply, the person must have a reasonable belief the pet is in imminent danger, attempt to locate the driver, take reasonable steps to restore or ensure the animal's well-being, use no more force than necessary and leave notice on or in the vehicle.

**Drone Regulations (HB 1346 – awaiting Senate action):** Establishes the crime of "unlawful use of unmanned aircraft" to better regulate the use of drones in the Commonwealth.

**Use of Flashing Lights (HB 1414 – awaiting Senate action):** Authorizes the use of flashing yellow and white lights on tow trucks, yellow strobe lights for solid waste collection vehicles, mounted internal blue lights for volunteer firefighters and flashing or revolving lights internally mounted in the passenger compartment of privately owned vehicles used in answering emergency calls when used by certain fire police, and amends the definition of "emergency vehicle."

**DNA Collection (HB 1523 – awaiting Senate action):** Outlines new standards for the collection, analysis and use of DNA samples, and storage of DNA profiles in the State DNA Database for comparison with DNA profiles collected during criminal investigations. It also makes changes to the law to reflect current DNA testing terminology and techniques.

**Restitution for Entities, Organizations (HB 1806 – awaiting Senate action):** Amends the definition of "victim" in the Crime Victims law to include all crime victims, not just individuals. The bill is in response to a recent Pennsylvania Supreme Court ruling, which vacated a former representative's restitution order for using state resources to run campaigns. The court found that the Commonwealth cannot be a victim as the definition of victim under law only refers to individuals and their family members. The law could also aid other government entities and organizations.

**Rape Kit Testing (HB 1821 – awaiting Senate action):** Amends the Sexual Assault Testing and Evidence Collection Act regarding timeframes for the submission of sexual assault evidence.

**First Chance Fund (HB 1929 – included in Act 42 of 2018, the 2018-19 Fiscal Code):** Amends the First Chance Fund to benefit children who are the victims of violent crime or whose parents or guardians are the victims of violent crime.

**Ensuring Victim Rights (HB 1974 -- awaiting Senate action):** Amends the Pennsylvania Crime Victims Act to strengthen a victim’s right to be present during trial proceedings.

### **Crime Victim Protections**

**Marsy’s Law (SB 1011 – passed both House and Senate; identical measure must pass House and Senate in 2019-20 legislative session):** Proposes an amendment to the Pennsylvania Constitution to set forth specific rights for victims of crimes. Marsy’s Law is named for Marsalee (Marsy) Nicholas, a California college student who was shot and killed by her ex-boyfriend in 1983. Only a week after her murder, Marsy’s brother and mother walked into a grocery store and were confronted by the accused murder, whom the family had no idea had been released on bail. Marsy’s family has since championed for rights to victims and their families.

### ***Bills Awaiting Further Legislative Action***

**Tender Years Exception (HB 2321 – awaiting Senate action):** Adds several crimes to the existing provision which permits a court to admit an out-of-court statement of a child victim or child witness.

**Rape Shield Law (HB 2324 – awaiting Senate action):** Amends the Rape Shield Law in order to exclude from criminal trials evidence of “past sexual victimization.”

**Victims/Witnesses with Intellectual Disabilities (HB 2325 – awaiting Senate action):** Addresses the admissibility of out-of-court statements in criminal or civil proceedings made by an individual with an intellectual disability or autism who is a victim or witness.

### **Health Care and Health Care Access**

**Civil Immunity for Epinephrine Administration (Act 2 of 2017):** Applies civil immunities to school bus drivers or crossing guards who administer an epinephrine auto-injector to a student.

**Improving Care for Stroke Victims (Act 4 of 2017):** Adds acute stroke-ready hospitals and comprehensive stroke center designations to the state’s Stroke System of Care Act. The system is designed to improve health outcomes for stroke victims.

**Fighting Rare Diseases (Act 14 of 2017):** Establishes a Rare Disease Advisory Council within the Pennsylvania Department of Health to study the incidence and prevalence of rare diseases in Pennsylvania.

**Death Certificates (Act 17 of 2017):** Allows a physician assistant (PA) to sign a death certificate for a patient under his or her care.

**Right to Try (Act 33 of 2017):** Allows eligible, terminally ill patients to request and use investigational drugs, biological products and medical devices not yet approved by the U.S. Food and Drug Administration.

**Supporting Pediatric Cancer Research (Act 39 of 2017):** Creates an opportunity for taxpayers to donate to pediatric cancer research via their Pennsylvania tax returns.

**CHIP Extension (Act 58 of 2017):** Reauthorizes the Children's Health Insurance Program (CHIP) until Dec. 31, 2019. CHIP provides insurance coverage to uninsured children and teens (up to age 19) whose families earn too much to qualify for Medical Assistance, but who cannot afford to purchase private insurance.

**Ambulatory Surgery Center (Act 70 of 2017):** Amends the Health Care Facilities Act to change the length of stay in a licensed Ambulatory Surgery Center (ASC) to comport with that of other states and federal Centers for Medicare and Medicaid Services (CMS) guidelines.

**ABC-MAP Changes (Act 79 of 2017):** Amends the Achieving Better Care by Monitoring All Prescriptions Program to exempt prescribers from the requirement to query the database when non-narcotic Schedule V drugs are prescribed to treat epilepsy or a seizure disorder.

**Prescription Refills (Act 8 of 2018):** Permits pharmacists to dispense emergency prescription refills for up to 30 days pursuant to certain restrictions and allows for refills of medications which are not dispensed or sold in 72-hour supplies.

**Maternal Mortality Review (Act 24 of 2018):** Establishes the Maternal Mortality Review Committee within the Department of Health to review maternal deaths in the Commonwealth and to develop strategies for the prevention of maternal deaths.

**Psychiatric Supervision (Act 25 of 2018):** Changes the number of hours of psychiatric supervision required at outpatient psychiatric clinics to help meet growing demand and address the shortage of psychiatric time in Pennsylvania. The legislation will allow licensed prescribing professionals to work within their scope of practice as is the case in the physical health care arena.

**Chiropractic Students (Act 67 of 2018):** Authorizes students in chiropractic schools to perform, under the direct, immediate and personal supervision of a licensed chiropractor, chiropractic activities as part of their clinical training.

**Pediatric Cancer Research Funding (Act 73 of 2018):** Requires the Pennsylvania Department of Transportation to establish a method to accept \$5 contributions for the Pediatric Cancer Research Fund from persons renewing licenses, identification cards and registrations through web-based online transactions.

**Ensuring Better Treatment (Act 76 of 2018):** Amends the Social Workers, Marriage and Family Therapists and Professional Counselors Act to require individuals who engage in the independent practice of clinical social work, marriage and family therapy or professional counseling to be licensed.

### *Bills Awaiting Further Legislative Action*

**Health Insurance for Children (HB 114 – awaiting Senate action):** Requires the non-custodial parent of children for whom Medical Assistance is sought to enroll the children in their own health insurance plan.

**Credentialing (HB 125 – awaiting Senate action):** Creates the Health Care Practitioner Credentialing Act to outline the use of certain credentialing applications and credentialing requirements for health insurers.

**Access to Epinephrine (HB 126 – awaiting Senate action):** Permits authorized entities with properly trained employees to maintain a supply of epinephrine auto-injectors and provide or administer them.

**Lyme Disease Treatment (HB 174 – awaiting Senate action):** Requires health insurers to cover treatment plans for Lyme disease or related tick-borne illnesses as prescribed by a patient's health care practitioner, regardless if the treatment plan includes short-term or long-term antibiotic treatment.

**Postpartum Depression (HB 200 – awaiting Senate action):** Adds postpartum depression as a qualifying at-risk condition for early intervention services under the Early Intervention Services System Act.

**Health Services for Minors (HB 381 – awaiting Senate action):** Requires the Department of Human Services to issue guidelines and clarify regulations regarding when a minor's consent is needed for mental health examinations or other services.

**ABC-MAP Update (HB 395 – awaiting Senate action):** Amends the Achieving Better Care by Monitoring All Prescriptions Program Act to exempt prescribers from the requirement to query the database when Schedule V drugs are prescribed to treat epilepsy or a seizure disorder.

**Social Worker Licensure (HB 445 – awaiting Senate action):** Updates license requirements to include individuals who engage in the independent practice of clinical social work with the goal of ensuring better treatment for patients in need of the service.

**Pharmacy Tech Registration (HB 454 – awaiting Senate action):** Requires pharmacy technicians to be registered with the State Board of Pharmacy.

**Federally Qualified Health Centers (HB 644 – awaiting Senate action):** Removes the cap on funds that may be obtained by federally qualified health centers through the Community Based Health Care Act.

**Patients' Rights (HB 835 – awaiting Senate action):** Specifies that Pennsylvanians receiving mental health treatment have the right to be free from abuse, neglect and exploitation.

**Protecting Against Obesity (HB 899 – awaiting Senate action):** Adds anti-obesity medications approved by the United States Food and Drug Administration (FDA) to the list of items which shall be considered a compensable item under the medical assistance program.

**Pain Clinic Registration (HB 1043 – awaiting Senate action):** Requires pain management clinics to register with the Pennsylvania Department of Health and be subject to specific regulations.

**Mental Health Treatment (HB 1233 – awaiting Senate action):** Establishes a new standard for assisted outpatient mental health treatment for seriously mentally ill individuals.

**Access to Treatment (HB 1280 – awaiting Senate action):** Grants Stage IV metastatic cancer patients access to the medication and treatments prescribed by their doctors rather than having to first try a series of insurance-mandated medications.

**Office of Independent Medical Assistance Director (HB 1354 – awaiting Senate action):** Creates the Office of Independent Medical Assistance Director within the Department of Human Services (DHS) for budgetary purposes.

**Early Childhood Vision Care Education (HB 1514 – awaiting Senate action):** Directs the Department of Health to establish the Early Childhood Vision Care Education Program.

**Prescription Drug Database Access (HB 1532 – awaiting Senate action):** Amends the Achieving Better Care by Monitoring All Prescriptions program to allow Medicaid Managed Care Organizations (MA MCOs) to query the system for individuals who are served by the MA MCO. The query may include both dispensing and prescribing information to help better identify potential prescription drug abuse among individuals enrolled in the state's Medicaid program.

**PA Health Care Cost Containment Council (HB 1613 – awaiting Senate action):** Reauthorizes and modernizes the Pennsylvania Health Care Cost Containment Council (PHC4).

**Medical Service Agreement Act (HB 1739 – awaiting Senate action):** Establishes the Medical Service Agreement Act to allow for direct primary care services through a written subscription agreement.

**Medication Synchronization (HB 1800 – awaiting Senate action):** Allows pharmacies the ability to synchronize multiple medication fill dates by prohibiting insurers from denying coverage for prescriptions filled by medication synchronization on the basis that it is a partial fill of the prescription.

**Program Eligibility (HB 1829 – awaiting Senate action):** Establishes a deemed eligibility program for home care and home health care services and older adult daily living center services.

**Medical Imaging Results (HB 1884 – awaiting Senate action):** Requires that the results of imaging studies be provided directly to patients within 20 days if there is a finding of an abnormality which requires follow-up care within three months.

**Eligibility for In-Patient Services (HB 1997 – awaiting Senate action):** Establishes a deemed eligibility program for in-patient behavioral health services.

**Nicotine Products, Delivery Products (HB 2226 – awaiting Senate action):** Prohibits the sale or purchase of nicotine products or nicotine delivery products to or by minors.

**Nicotine Products, Delivery Products in Schools (HB 2268 – awaiting Senate action):** Bans nicotine-based products, nicotine delivery products and electronic cigarettes in Pennsylvania schools.

**Organ Donation (SB 180):** Makes several updates to the state’s organ donation laws.

### **Senior Citizens**

**PACE/PACENET Eligibility (Act 62 of 2017):** Ensures senior citizens receiving PACE and PACENET prescription drug benefits do not lose eligibility due to a Social Security cost-of-living adjustment (COLA). The current law addressing the COLA is due to expire at the end of this year.

### ***Bills Awaiting Further Legislative Action***

**Reduced-Fee Vehicle Registration (HB 188 – awaiting Senate action):** Increases the annual income limit for retired persons receiving Social Security or other pension to qualify for the discounted \$10 vehicle registration fee.

**Prescription Assistance (HB 296 – awaiting Senate action):** Excludes from the definition of “income,” the principal and any interest accrued from a savings bond in determination of eligibility for PACE and PACENET.

**Protecting Against Scams (HB 448 – awaiting Senate action):** Requires the Pennsylvania Office of Attorney General to establish ongoing communication with the Pennsylvania Department of Aging in an effort to further identify potential patterns of financial exploitation of seniors.

### **Military and Veterans Affairs**

**Stolen Valor (Act 9 of 2017):** Establishes the crime of “misrepresentation of military service or honors” for anyone fraudulently presenting oneself as a member or veteran of any branch of the armed forces, or as the recipient of a service medal or other military decoration, when it is done with the intention of obtaining money, property or other benefits.

**Elective Office for Active Duty Military (Act 54 of 2017):** Establishes uniform residential qualifications for election/appointment to municipal elected office for active duty military personnel.



**Recognizing PA Veterans (Act 56 of 2017):** Creates and adds the Pennsylvania Medal of Achievement and the Pennsylvania Veterans Service Award to the list of existing medals, badges and awards that are authorized and presented by the governor in the name of the Commonwealth.

**Veterans Registry (Act 69 of 2017):** Requires the Department of Military and Veterans Affairs to enhance its veterans registry for outreach purposes.

**National Guard Youth Challenge (Act 51 of 2018):** Requires the Department of Military and Veterans Affairs to establish in Pennsylvania the National Guard Youth Challenge Program, a dropout recovery program that helps at-risk young people earn a high school diploma or its equivalent and move on to higher education, employment or military service.

**PA Veterans' Monuments and Memorial Trust Fund (Act 64 of 2018):** Changes the name of the "PA Veterans' Memorial Trust Fund" to the "PA Veterans' Monuments and Memorial Trust Fund" and enhances the fund to better preserve monuments and memorials dedicated to Pennsylvania's veterans and military personnel.

### *Bills Awaiting Further Legislative Action*

**Civil Air Patrol Expenditures (HB 204 – awaiting Senate action):** Authorizes the Department of Military and Veterans Affairs to operate as liaison for the Civil Air Patrol and supervise the expenditures of state funding as well as the maintenance and use of Commonwealth facilities by the Civil Air Patrol.

**Honoring Women Veterans (HB 215 – awaiting Senate action):** Establishes the "Honoring Our Women Veterans" special license plate to display on passenger cars or trucks.

**Military Training Consideration (HB 302 – awaiting Senate action):** Adds the Department of Health to the list of agencies required to consider a service member's military education and training for the purpose of fulfilling requirements for licensure/certification in the Commonwealth.

**Prescription Drug Assistance for Veterans (HB 673 – awaiting Senate action):** Eliminates veterans' benefits from the definition of "income" when determining an individual's eligibility for the PACE and PACENET programs.

**Veterans Compensation Exclusion (HB 980 – awaiting Senate action):** Excludes veterans' compensation benefits from income calculations for Commonwealth programs.

**Military Family Relief Funding (HB 984 – awaiting Senate action):** Extends the income tax check-off for the Military Family Relief Fund in perpetuity. The fund provides financial assistance to armed forces personnel and their families, including the National Guard and the Reserve components. The assistance available under this program is immediate and can be used for food,

shelter, clothing and necessary medical care that is due to a member's active duty status, such as deployment overseas.

**Elected Official Qualifications (HB 1363 – awaiting Senate action):** Establishes uniform residential qualifications for election/appointment to municipal elected office for active military duty personnel.

### **Emergency Responders**

**Ambulance Service Reimbursement Rates (HB 699 – included in Act 42 of 2018, the 2018-19 Fiscal Code):** Requires an increase in the Medical Assistance reimbursement rates for services provided by both ground and air ambulance companies.

### ***Bills Awaiting Further Legislative Action***

**First Responders Day (HB 760 – awaiting Senate action):** Designates Sept. 27 of each year as “First Responders Day” in Pennsylvania.

**Treatment, No Transport (HB 1013 – awaiting Senate action):** To help ease the funding crisis for local ambulance service organizations, insurance companies would be required to reimburse ambulance organization for providing medical treatment, even when a patient is not transported to a hospital.

### **Sportsmen**

**Protecting Honest Hunters (Act 3 of 2018):** Amends the Game and Wildlife Code to include bear and elk in the mistaken kill provisions; establish restitution and clemency from license revocation; allow for the continued use of recording devices by Wildlife Conservation Officers; and establish that violators adhering to a payment plan to repay penalties may not have their hunting license suspended.

**Use of Tracking Dogs (Act 11 of 2018):** Allows the use of leashed tracking dogs to track and recover legally wounded or harvested white-tailed deer, black bear and elk during any open season for deer, bear or elk.

**Accidental Taking (Act 3 of 2018):** Includes bear and elk in the law allowing hunters who mistakenly take an animal to turn themselves in to the Pennsylvania Game Commission and pay a small fine but avoid revocation of their hunting licenses.

### ***Bills Awaiting Further Legislative Action***

**Hunter Education Courses (HB 397 – awaiting Senate action):** Expands the availability of certified hunter education courses in public schools.

**Mentored Hunting Programs (HB 485 – awaiting Senate action):** Expands Pennsylvania’s mentored hunting programs to include youth ages 12-17. The program is currently available to children under 12 and to adults ages 18 and older.

**Discount for HTE Instructors (HB 582 – awaiting Senate action):** Creates a “Volunteer Instructor License” to provide a discounted hunting license for volunteer Hunter Trapper Education instructors.

**Supporting Therapeutic Recreation (HB 675 – awaiting Senate action):** Provides an exemption from fishing license requirements for therapeutic recreation programs.

**Military Fishing/Hunting Licenses (HB 1153 – awaiting Senate action):** Authorizes the Pennsylvania attorney general to enter into reciprocal agreements with other states allowing active duty military fishing and hunting licenses and grants recognition of licenses issued by other states.

**Discounts for Veterans (HB 1409 – awaiting Senate action):** Amends the Game and Wildlife Code to allow qualified nonresident disabled veterans and former prisoners of war to receive the same licensing discounts and exemptions currently given to resident disabled veterans and former prisoners of war and exempts senior lifetime hunting and furtaking license holders from any permits required to hunt game animals previously allowed under their lifetime licenses.

### **Consumer Protection**

**Household Movers (Act 77 of 2017):** Establishes administrative penalties for persons or companies, operating without Public Utility Commission certification, that transport household property between residential dwellings in the Commonwealth for compensation.

**Licensee Disciplinary Actions (Act 6 of 2018):** Requires licensees of all boards within the Bureau of Professional and Occupational Affairs (BPOA) to report any disciplinary action taken by another licensing agency of another state, and any felony or misdemeanor offenses to their licensing board within 30 days. The bill also gives all boards and commissions under BPOA temporary license suspension authority and authorizes the commissioner of the BPOA to expunge minor disciplinary records.

**Community Dispute Resolution (Act 17 of 2018):** Grants the power to investigate and mediate disputes in planned communities, cooperatives and condominiums to the Bureau of Consumer Protection in the Office of Attorney General.

**No GRT for Mobile Telecommunications (Act 52 of 2018):** Protects mobile telecommunications consumers from double taxation by excluding the sales of telephones, telephone handsets, modems, tablets and related accessories, including cases, chargers, holsters, clips, hands-free devices, screen protectors and batteries from being subject to the gross receipts tax.

**Fraudulent Credit Card Devices (Act 60 of 2018):** Updates Pennsylvania law regarding prevention, elimination and punishment of the use of fraudulent credit card devices.

### ***Bills Awaiting Further Legislative Action***

**Motorcycle Lemons (HB 74 – awaiting Senate action):** Includes motorcycles on the list of vehicles covered under the Automobile Lemon Law.

**Do-Not-Call List (HB 105 – awaiting Senate action):** Allows subscribers to remain on the “do-not-call” list permanently, prohibits telemarketing on legal holidays, and requires a telemarketer using a robocall system to have an opt-out provision during the phone call.

**Protection of Pension Funds (HB 324 – awaiting Senate action):** Protects pensioners whose pensions are sold to insurance companies, when the Employment Retirement Income Security Act no longer applies.

**Plumber Licensure (HB 442 – awaiting Senate action):** Establishes the State Board of Plumbing Contractors within the Department of Labor and Industry and requires licensure for those who hold themselves out to the public as a “master plumber,” journeyman plumber,” “apprentice plumber” or a “licensed plumbing contractor.”

**Tattoo and Body Piercing Safety Standards (HB 456 – awaiting Senate action):** Directs the Department of Health to establish sterilization, sanitation and safety standards for any business engaged in tattooing or body piercing, and creates a central registry within the department for persons performing tattooing or body piercing and for establishments where such procedures are performed.

**Credit Report Security (HB 1094 – awaiting Senate action):** Eliminates the automatic expiration of security freezes on consumer credit reports and provides for security freezes for “protected persons.”

**Certificate of Theft (HB 1240 – awaiting Senate action):** Limits when a vehicle owner must apply for a certificate of title branded as a theft vehicle and establishes restrictions for self-insurers.

**Online Booking for Lodging (HB 1810 – awaiting Senate action):** Requires online hosting platforms that facilitate the booking of overnight lodging in Pennsylvania to register with the Department of Revenue.

**Data Breach Notification Requirements (HB 1846 – awaiting Senate action):** Requires notice within 45 days to residents of the Commonwealth when there is a breach of security of a system. The notice must be in plain language, and include the date of the breach, the type of information subject to the breach, and toll-free numbers to credit reporting agencies.

**Credit Freeze and Monitoring Services (HB 1847 – awaiting Senate Action):** Amends the Credit Reporting Agency Act to waive the current fee to freeze a credit report, which is \$10 for each request, should a data breach occur. In the instance of a data breach, consumers would be provided with three months of free credit monitoring and up to three free credit reports for one calendar year after the date the breach is reported.

**Lead Water Line Replacements (HB 2075 – awaiting Senate action):** Encourages regulated water and wastewater utilities to proactively replace lead water service lines in the communities they serve by allowing them to recover costs incurred to replace these customer-owned lines.

**Pharmacy Fairness and Reimbursement Rates (HBs 2211-2212 – awaiting Senate action):** Aims to protect consumers and independent pharmacies from unfair drug prices and reimbursement rates by prohibiting “gag clauses” and ensuring pharmacists may disclose drug cost information to consumers, allowing them to shop for the best prices for their medications (HB 2211) and preventing pharmacy benefit managers from cutting reimbursements to community pharmacies for medications sold to patients on Medicaid (HB 2212).

### **Stronger Communities and Local Government**

**Township Vacancy Procedures (Acts 16 and 23 of 2017):** Amends the First Class Township Code and Second Class Township Code to address vacancies created as a result of the resignation of an elected official.

**Construction Extension (Act 19 of 2017):** Grants municipal authorities which serve five or more municipalities an additional five years to begin certain construction projects.

**Second Class Township Code (Act 28 of 2017):** Amends the Second Class Township Code to allow township supervisors to hold certain appointed positions.

**Cemetery Access (Act 64 of 2017):** Ensures reasonable access to cemeteries to anyone for the purpose of visitation, and establishes procedures for the sale and purchase of a cemetery, and continuation of honoring purchased burial plots.

**Pittsburgh Water and Sewer Authority (Act 65 of 2017):** Places the Pittsburgh Water and Sewer Authority under the oversight of the Public Utility Commission.

**Bingo Law Updates (Act 66 of 2017):** Makes several updates to the Bingo Law, including allowing increased bingo prize limits, daily operation of bingo and advertisement of prize amounts) to help maximize opportunities for fundraising for community nonprofit organizations.

**Property Foreclosure (Act 32 of 2018):** Establishes an accelerated foreclosure process for vacant and abandoned properties.

**Eminent Domain Reform (Act 45 of 2018):** Establishes limitations on the ability to use eminent domain on land that has been permanently preserved through a conservation easement.

### ***Bills Awaiting Further Legislative Action***

**Emergency Contracts (HB 99 – awaiting Senate action):** Allows boroughs to make contracts or purchases without requiring advertising, bidding or price quotations in situations deemed emergencies.

**Transfer of Water/Sewer Infrastructure (HB 104 – awaiting Senate action):** Requires a municipal authority to publicly discuss all acquisitions and the sale or transfer of authority-owned water and sewer infrastructure and how the acquisition or sale will benefit the authority’s existing ratepayers and requires annual reports within 180 days of the end of an authority’s fiscal year.

**Charity Fundraising (HB 144 – awaiting Senate action):** Aims to ease some regulatory burdens placed on community nonprofit organizations in their fundraising activities.

**Pennsylvania Building Codes (HB 162 – awaiting Senate action):** Amends the Pennsylvania Construction Code Act to give the Department of Labor and Industry the authority to contract with the International Codes Council to create a Pennsylvania-specific set of code books and require that such code books be available online in “read only” format to the general public.

**2-1-1 Grant Program (HB 211 – awaiting Senate action):** Establishes the Statewide 2-1-1 System Grant Program within the Department of Human Services to facilitate dissemination of health and human service information.

**Municipal Boards of Appeals (HB 266 – awaiting Senate action):** Amends the Pennsylvania Construction Code regarding the number and qualifications of persons serving on municipal boards of appeals.

**Selling Municipal Water, Sewer Systems (HB 477 – awaiting Senate action):** Requires municipalities to host publicly noticed meetings when considering selling or leasing a sewer or water system.

**Encouraging Intergovernmental Cooperation (HBs 479-481 – awaiting Senate action):** This package of bills is designed to make it easier and less costly for municipalities to work together. **House Bill 479** allows intergovernmental cooperation by resolution unless the authorizing statute requires an ordinance. **House Bill 480** amends the Second Class Township Code to delete the phrase “by ordinance” from the provisions governing intergovernmental cooperation agreements. **House Bill 481** amends the Third Class City Code to delete the phrase “by ordinance” from the provisions governing intergovernmental cooperation agreements.

**Cross-Filing Nomination Petitions (HB 638 – awaiting Senate action):** Removes the ability of candidates for school board to cross-file nomination petitions.

**Neighborhood Assistance Program Funding (HB 645 – awaiting Senate action):** Doubles the amount of available tax credits from \$18 million to \$36 million in the Neighborhood Assistance Program. The goal of the program is to improve the lives of low-income people in distressed neighborhoods through the creation of an effective partnership between community-based organizations and the business and corporate community. In order to be eligible for the tax credit, an applicant must qualify under one or more of the following categories: community service, education, job training, crime prevention, and/or neighborhood assistance.

**Storm Water Management (HBs 913-916 – awaiting Senate action):** Gives boroughs, townships, cities of the third class and the Town of Bloomsburg the authority to implement storm water management ordinances and to assess a fee to fund the planning, management, implementation, construction and maintenance of storm water facilities.

**Leaf Waste Exemption (HB 927 – awaiting Senate action):** Exempts municipalities meeting a population density threshold from establishing a leaf waste collection program.

**County Jail Board Meetings (HB 973 – awaiting Senate action):** Changes the frequency and location for meetings of a county jail board of inspectors in an eighth-class county.

**Municipal Authority Collections (HB 1034 – awaiting Senate action):** Adds additional fiscal procedures for the collection of money by municipal authorities.

**Appointment of Wards (HB 1362 – awaiting Senate action):** Establishes a statutory mechanism for the initial and subsequent apportionment of wards in a home rule charter or optional plan municipality without a mayor.

**Bids for Services (HB 1364 – awaiting Senate action):** Authorizes political subdivisions and authorities to enter into contracts for services when two consecutive advertisements fail to induce bids.

**Delinquent Property Ownership (HB 1814 – awaiting Senate action):** Clarifies ownership of properties delinquent in real estate taxes and in the process of being sold through the Real Estate Tax Sale Law.

**Increased Bidding Threshold (HBs 1887-1889 – awaiting Senate action):** Increases from \$1,000 to \$2,000 the value of municipal personal property below which a first-class township (HB 1887), a borough or third-class city (HB 1888) and an incorporated town (HB 1889) need not publicly advertise for bids when selling its personal property.

**Addressing Squatters (HB 1931 – awaiting Senate action):** Gives police the authority to remove a person from a residential property that they have probable cause to believe is illegally trespassing or squatting.

**Municipal Electric Consumers (HB 2030 – awaiting Senate action):** Standardizes the process for billing municipal electric customers in boroughs situate in more than one county.

**Land Bank Jurisdiction (SB 667 – awaiting Senate action):** Allows a land bank jurisdiction located in a county of the second class A through eighth class to designate a redevelopment authority, which was created for the jurisdiction, as the land bank.

**Delinquent Properties (SB 851 – awaiting Senate action):** Clarifies ownership of properties delinquent in real estate taxes and in the process of being sold through the Real Estate Tax Sale Law.

### **Supporting Adoption**

#### ***Bills Awaiting Further Legislative Action***

**Access to Adoption Counseling (HB 56 – awaiting Senate action):** Ensures that birth parents, if they so desire, have access to adoption-related counseling services when they are considering relinquishing parental rights and placing a child for adoption, or when they have relinquished parental rights and have consented to place their child for adoption.

**Termination of Parental Rights (HB 57 – awaiting Senate action):** Streamlines and expedites the procedures for terminating parental rights in the course of the legal process to adopt a child in Pennsylvania.

**Revoking Consent to Adoption (HB 58 – awaiting Senate action):** Shortens the period in which a birth mother, birth father or putative father can revoke his or her consent to an adoption from 30 days to 14 days.

**Witnessing Consent to Adoption (HB 61 – awaiting Senate action):** Clarifies that an employee of a correctional facility may serve as a signed witness to the execution of a consent to adoption by a birth parent who is incarcerated.

**No Required Hearing (HB 62 – awaiting Senate action):** Eliminates the requirement of holding a hearing to confirm a consent to an adoption when the birth parent or parents of the child being placed for adoption have executed valid consents to an adoption.

**Defining Intermediary (HB 63 – awaiting Senate action):** Amends the definition of the term “intermediary” in adoption law to include licensed attorneys or licensed social workers who are acting in that capacity.

**Reimbursable Expenses (HB 289 – awaiting Senate action):** Adds reasonable living expenses incurred by a birth mother of a child being placed for adoption to the list of expenses currently permitted to be reimbursed in an adoption process and paid by the adoptive parents; eliminates a report of intermediary; and requires the inclusion of specific documents as exhibits to the petition for adoption.



## Miscellaneous

**REAL ID Compliance (Act 3 of 2017):** Adopts policies to bring Pennsylvania into compliance with the federal REAL ID Act. When the REAL ID components are fully implemented, which is expected to take a year or more, residents will have the option of choosing a REAL ID-compliant form of identification or the standard form. The REAL ID will require more documentation to obtain, such as a birth certificate with a raised seal and proof of legal residency, and will likely cost more than the standard form.

**PIDA Project Inspections (Act 7 of 2017):** Amends the Commerce and Trade law to define the term “agent” to include the Department of Community and Economic Development, giving it and its employees the ability to conduct required inspections and monitoring programs managed by the Pennsylvania Industrial Development Authority. The measure also transfers the Concert Facility Tax Credit to Commerce and Trade.

**Personal Property Sale (Act 21 of 2017):** Increases the threshold for the sale of personal property without public notice or the acceptance of bids from \$1,000 to \$2,000.

**Uniform Construction Code Updates (Act 36 of 2017):** Makes comprehensive changes to the process used by the Uniform Construction Code Review and Advisory Council to evaluate and adopt building code updates.

**Payment to Decedent’s Family (Act 41 of 2017):** Increases the amount of wages, salary or employee benefits that may be paid directly by an employer to the family of a decedent from \$5,000 to \$10,000 without requiring letters of administration.

**Apportionment of Wards (Act 53 of 2017):** Establishes a statutory mechanism for the initial and subsequent apportionment of wards in a home rule charter or optional plan municipality without a mayor.

**Underground Storage Tanks (Act 61 of 2017):** Amends the Storage Tank and Spill Prevention Act to address a vacancy on the Underground Storage Tank Indemnification Board; adjusts allocations for different types of grants and extends the program sunset dates by five years.

**Pittsburgh Parking Authority (Act 76 of 2018):** Authorizes the Pittsburgh Parking Authority to designate certain parking areas for residential and commercial use.

**Uniform Voidable Transactions (Act 78 of 2017):** Establishes the Pennsylvania Uniform Voidable Transactions Act to amend Pennsylvania law on fraudulent transfers.

**Parking Authority Powers (Act 80 of 2017):** Delegates powers to parking authorities of cities of second class A and third class.

**Non-Bank Mortgage Entities (Act 81 of 2017):** Amends the Banks and Banking law regarding the licensure and regulation of non-bank mortgage servicing entities.

**Soliciting Funds for Charities (Acts 71 and 72 of 2017):** Amends the Solicitation of Funds for Charitable Purposes Act to align the audit requirements for financial reports with federal law (Act 71) and to make technical changes that will assist organizations filing a registration statement with the Department of State's Bureau of Corporations and Charitable Organizations (Act 72).

**Disciplinary Actions Against Licensed Professionals (Act 6 of 2018):** Requires licensees of all boards within the Bureau of Professional and Occupational Affairs (BPOA) to report any disciplinary actions taken by another licensing agency, and any felony, misdemeanor and drug- or alcohol-related summary convictions, to their licensing board within 30 days. The bill also gives all boards and commissions under BPOA temporary and automatic license suspension authority and authorizes the Commissioner of the BPOA to expunge minor disciplinary records.

**Solid Waste Management (Act 7 of 2018):** Amends the Solid Waste Management Act to eliminate iron and steel slag from the definition of "residual waste."

**Insurance Marketing (Acts 22 and 23 of 2018):** Amend the Insurance Department Act (Act 22) and the Insurance Company Law (Act 23) to allow producers and insurers to offer or give to an insured or prospective insured a rebate or inducement at a value of \$100 or less.

**Travel Insurance Requirements (Act 26 of 2018):** Establishes the Travel Insurance Modernization Act to reform insurance licensure requirements relating to travel retailers who offer travel insurance coverage.

**United States Semiquincentennial Celebration (Act 28 of 2018):** Creates the Pennsylvania Commission for the United States Semiquincentennial.

**Insurance Department Exams (Act 41 of 2018):** Requires the Pennsylvania Insurance Department to formalize its exam process with best practices.

**Life Insurance Database (Act 48 of 2018):** Establishes a searchable electronic database, maintained by the Pennsylvania Insurance Department or its designee, containing contact information for each life insurer that has life insurance policies in force in Pennsylvania.

**Collaborative Law (Act 55 of 2018):** Creates a uniform standard of practice for collaborative law in Pennsylvania. Collaborative law is a voluntary alternative dispute resolution process for parties who seek resolution of their legal matter outside of the courtroom. The use of collaborative law to settle a dispute is entirely voluntary and cannot be court ordered.

**Instruments Under Seal (Act 46 of 2018):** Removes the sunset date for the 20-year statute of limitations on actions on "instruments under seal."

**Public Utility Rates (Act 58 of 2018):** Authorizes the use of alternative rate mechanisms by public utilities to help the utilities adapt to the evolving electric industry.

**Vehicle Dealers (Act 59 of 2018):** Amends the Board of Vehicles Act to address issues regarding used vehicles with unrepaired recalls, prohibits manufacturers from requiring dealers to significantly modify facilities within 10 years of a prior modification, and establishes a temporary license for new vehicle dealers.

**Jail Board Meetings (Act 63 of 2018):** Changes the frequency and location for meetings of a county jail board of inspectors in an eighth-class county.

**Southeastern Pennsylvania Veterans' Center (Act 66 of 2018):** Authorizes the Department of General Services to extend the terms of a lease of a portion of the Southeastern Pennsylvania Veterans' Center property.

**Civil Service Commission Reforms (Act 71 of 2018):** Transfers duties relating to merit-based hiring, civil service applications, certifications, examinations and promotions from the Civil Service Commission to the Office of Administration. The goal is to modernize and streamline the system to better meet the needs of people seeking employment in the Commonwealth.

**Theft Vehicles (Act 74 of 2018):** Limits when a vehicle owner must apply for a certificate of title branded as a theft vehicle and establishes restrictions for self-insurers.

**Real Estate Licensing (Act 75 of 2018):** Updates the Real Estate Licensing and Registration Act to increase the educational requirements for the salesperson license and to authorize brokers and salespersons to prepare Broker Price Opinions.

### *Bills Awaiting Further Legislative Action*

**Plastic Bag Surcharges (HB 1071 – VETOED BY THE GOVERNOR):** *Prohibits a political subdivision from imposing a ban, fee, surcharge or tax on a recyclable plastic bag supplied by a retail establishment to a purchaser of consumer goods at the point of sale.*

**Updating PA History Code (HB 157 – awaiting Senate action):** Modernizes the History Code with regard to the administration of the State Archives, archival records and other matters.

**Driver's License Suspension Changes (HB 163 – awaiting Senate action):** Eliminates the mandatory driver's license suspension for state or federal drug/controlled substance convictions, as well as state-imposed suspensions for six other crimes.

**Election Watcher (HB 171 – awaiting Senate action):** Permits a registered voter of the Commonwealth to be appointed as a watcher in any election district located in Pennsylvania.

**Architects Continuing Education (HB 223 – awaiting Senate action):** Establishes a continuing education requirement for architects.

**Building Code Official Certification (HB 298 – awaiting Senate action):** Amends the Pennsylvania Construction Code to allow the Department of Labor and Industry to create a separate “on-the-job” trainee classification for each building code official certification.

**Acquisition of Title (HB 352 – awaiting Senate action):** Reduces the standard period from 21 years to 10 years for bringing an action for the acquisition of title to real property through adverse possession under certain circumstances.

**MPOETC Makeup (HB 360 – awaiting Senate action):** Changes the composition of the membership of the Municipal Police Officers Education and Training Commission by eliminating the seat occupied by a Federal Bureau of Investigation special agent in charge and replacing it with a member of the Pennsylvania Lodge Fraternal Order of Police.

**School Director Nominating Petitions (HB 444 – awaiting Senate action):** Amends the Pennsylvania Election Code to establish the number of signatures that candidates for school director must collect on their nomination petitions.

**Self-Service Storage Insurance (HB 504 – awaiting Senate action):** Creates a limited license for self-service storage facilities to sell content insurance to individuals who rent self-service storage space from the owner of the facility.

**Assessor Certification (HB 539 – awaiting Senate action):** Amends the Assessors Certification Act to remove the exemption for counties of the first class (Philadelphia) from requirements regarding assessor certification.

**BPOA Licensee Convictions (HB 548 – awaiting Senate action):** Requires all licensees under the Bureau of Professional and Occupational Affairs to report convictions to their licensing board within 30 days.

**CDLs for Firefighters (HB 558 – awaiting Senate action):** Authorizes volunteer fire relief associations to use relief money to pay the cost of obtaining CDL licenses for firefighters to drive fire apparatus.

**Mortgage Servicers (HB 780 – awaiting Senate action):** Establishes licensure and regulation of mortgage servicers.

**Businesses Serving Casinos (HB 782 – awaiting Senate action):** Expedites Pennsylvania Gaming Control Board approval requirements for businesses that provide non-gaming-related goods and services to casinos.

**Tax Certification for Manufactured Homes (HB 783 – awaiting Senate action):** Exempts manufactured homes not previously titled in Pennsylvania from the tax certification requirement.

**Residual Waste Definition (HB 938 – awaiting Senate action):** Amends the Solid Waste Management Act to exempt iron and steel slag from the definition of “residual waste.”

**Alimony Pendente Lite (HB 983 – awaiting Senate action):** Prohibits the award of alimony pendente lite to a spouse who has been convicted of a personal injury crime against the other spouse.

**Home Inspector Licensing (HB 1001 – awaiting Senate action):** Creates the Home Inspector Licensing Act to establish the Home Inspector Licensing Board within the Department of Labor and Industry and require licensure in order to practice home inspection and use the title “Home Inspector.”

**Officiate Weddings (HB 1008 – awaiting Senate action):** Allows certain public officials to preside at weddings, including former mayors who have resigned the office without completing a full term, and former or retired justices, judges or magisterial district judges who are not serving in a senior capacity. The bill also eliminates the three-day waiting period for issuance of a marriage license.

**Savings Promotion Raffles (HB 1039 – awaiting Senate action):** Creates the Savings Promotion Raffle Authorization Act to authorize and permit financial institutions to conduct savings promotion raffles.

**Engineer/Land Surveyor Registration (HB 1106 – awaiting Senate action):** Amends the Engineer, Land Surveyor and Geologist Registration Law to clarify provisions and update the law to reflect current practice.

**Regulatory Cost Report (HB 1335 – awaiting Senate action):** Requires the Insurance Department to annually report to the General Assembly on the regulatory costs incurred by Pennsylvania’s domiciled insurers.

**Carryover of Continuing Education Credits (HB 1343 – awaiting Senate action):** Authorizes the state professional and occupational licensing boards to allow carryover of excess continuing education credits.

**Real Estate Appraisers (HB 1361 – awaiting Senate action):** Adds two certified Pennsylvania evaluators to the State Board of Certified Real Estate Appraisers.

**Barber Services (HB 1452 – awaiting Senate action):** Allows licensed barbers to provide free services outside of a licensed barber shop.

**Pension Management Fee Reporting (HB 1460 – awaiting Senate action):** Establishes standardized management fee reporting for SERS and PSERS developed by the Institutional Limited Partners Association’s (ILPA) Fee Transparency Initiative.

**Building Inspector Options (HB 1469 – awaiting Senate action):** Allows building permit applicants to use an alternative third-party agency in municipalities which have only one third-party agency enforcing the Uniform Construction Code (UCC), provided that the alternative third-party agency

remits a surcharge to the municipality; requires that building permit applications, in municipalities using one or more third-party agencies to enforce the UCC, contain a written notice on where complaints can be directed about the performance of such agencies; and establishes a process for the Department of Labor and Industry to investigate and remedy complaints about code officials.

**Planned Communities, Condos and Cooperatives (HB 1499 – awaiting Senate action):** Clarifies and updates provisions relating to planned communities, condominiums and cooperatives.

**Smart Meter Data Access (HB 1563 – awaiting Senate action):** Adds “government agencies” to the list of specific third parties for which customer consent is required prior to gaining direct access to customer meter data and meters.

**Certified Pennsylvania Evaluators (HB 1594 – awaiting Senate action):** Clarifies the qualifications and training of revaluation company personnel and Certified Pennsylvania Evaluators.

**Unemployment Comp Appeals (HB 1597 – awaiting Senate action):** Increases the period of time allotted for parties to appeal the determination of an Unemployment Compensation (UC) Service Center and the decision of a UC referee from 15 days to 21 days.

**Iran-Free Procurement (HB 1692 – awaiting Senate action):** Amends the Iran-Free Procurement Law to state that it may not expire until the Comprehensive Iran Sanctions, Accountability, and Divestment Act of 2010 is repealed by Congress.

**Register of Wills Requirement (HB 1885 – awaiting Senate action):** Allows the Register of Wills to require a personal representative to post additional security without court approval.

**Orphans’ Court Requirement (HB 1886 – awaiting Senate action):** Requires the Orphans’ Court to identify and take appropriate enforcement action against guardians who are delinquent in filing required annual reports.

**Humane Society Police Officers (HB 1917 – awaiting Senate action):** Strengthens the current training and oversight of humane society police officers.

**Service Animal Integrity Act (HB 2049 – awaiting Senate action):** Creates the Service Animal Integrity Act to address documentation requirements for service animals in housing, and to establish penalties for misrepresentation.

**Highway Vegetation (HB 2131 – awaiting Senate action):** Requires the Pennsylvania Department of Transportation to plant native species of vegetation along highways in Pennsylvania where feasible.

**Adoption Subsidies (HB 2213– awaiting Senate action):** Allows an adoptive family to appeal the amount of an adoption subsidy provided under the Adoption Opportunities Act.

**Check Cashier Licensing Act (HB 2453 – awaiting Senate action):** Amends the Check Cashier Licensing Act to update licensing, suspension and revocation provisions.

**Juneteenth National Freedom Day (HB 2488 – awaiting Senate action):** Establishes “Juneteenth National Freedom Day” as an annual observance for the Commonwealth.
